If your dog cannot receive vaccines due to a medical condition, we must have a statement signed by your veterinarian. Initial here: ☐

Please be aware that no vaccine will protect your pet from disease 100%, but it will decrease the risk of them becoming ill and will reduce the severity of the illness if it occurs. We require that your dog receive any needed vaccinations 7-10 days prior to their stay to start protecting your pet. Initial here: ☐

☐ **River City Pet Resort is closed on ALL national holidays. As such, we do not schedule arrivals or departures on those days. However, rest assured, there is still caretaking staff onsite to care for your pets. This includes New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas.**

☐ **Holiday stays must be pre-paid in advance. You will receive a full refund if canceled 3 weeks prior to the start of the stay. If canceled between 2-3 weeks prior, you will receive a credit on your account for use toward future stays or services. If canceled within 2 weeks or less no refund or credit will be issued**

☐ **If you pick up your pet(s) early from a stay that required prepayment, you will NOT receive reimbursement or account credit for doing so**

Please Initial in Acknowledgement of the Following River City Pet Resort Policies:

- ☐ If at any time the staff finds your pet is not doing well in daycare for any reason, they may be removed from group play at the discretion of the caretaking staff
- ☐ Dogs over 6 months of age must be spayed or neutered to participate in daycare
- ☐ A quick release collar is required to participate in daycare
- ☐ There is a risk of injury in a daycare setting. RCVH is NOT responsible for the cost of any injury or illness that may occur at our facility. This is a risk of participating in group play, and it is the responsibility of the owner to cover any and all cost associated with such situations
- ☐ RCVH does not recommend that you leave any toys, blankets, bedding, or other personal items with your pet. These items may become damaged or lost and are not the responsibility of RCVH. Toys and blankets will NOT be left with your pet in their suite overnight, as they could be chewed and ingested, causing gastrointestinal distress or obstruction
- ☐ RCVH reserves the right to use photos of your pet on the website, broadcast your pet live via the webcams, and/or in other marketing materials or social media websites
- ☐ RCVH will NOT perform any exams or surgeries while your pet is staying with us, unless illness or injury occurs. Presence of the client is a crucial component of your pet getting the treatment they deserve
- ☐ In the event of a life-threatening emergency, RCVH will treat your pet with the limited treatment necessary for life saving measures. The doctors and staff will always call you to seek authorization and direction for treatment in advance if time allows, but if you are unreachable or time does not allow, treatment will be given and you will be financially responsible
- ☐ Microbreeds (dogs under 10lbs) are not recommended for daycare. They are subject to additional risks participating in group play, including serious injury or death
- ☐ If you decide to pick up your pet(s) before the scheduled end of their boarding stay, we ask that you give us a courtesy call in advance to allow us time to prepare and have all your pet's belongings ready for departure.
- ☐ Please know the dates and days of your stay. During busy seasons we cannot accomodate extending reservations, and your emergency contact may be required to come pick up your pet(s)
- ☐ **There is an an additional charge of \$25 per pet if you pick up after 2pm**

All reasonable precautions will be used to prevent injury and escape of your pet. By signing this form, you acknowledge that you understand that the inherent risks of boarding and daycare may include injury, serious illness, or death. This is a risk that you must be willing to accept as animals can be unpredictable and RCVH will not be held responsible.

By signing this form, you are verifying that the above named dog is in good health, except as otherwise noted, and to your best knowledge has not shown clinical signs of any communicable disease within the last 14 days. If participating in daycare, you further certify that the dog has not caused harm to nor shown aggressive/threatening behavior towards people or dogs.
